Regulation Impact Assessment and Health Damage Analysis: Outdoor Worker Heat Protection Laws

Developed a quasi-experimental study of the health costs of heat. Incorporated Texan outdoor worker heat protection laws and state run workers' compensation data from the Texas Department of Insurance. Credibly quantified the cost of extreme heat to worker health, productivity, and public finances. **Techniques used to calculate health damages.**

Regulator Enforcement and Firm Compliance: Drinking Water Utility Compliance with Water Contamination Regulation

Developed a causal identification strategy and theoretical model to identify the response of firms and regulators to increases in output contamination. Integrated geospatial, geologic, firm, and regulator response data. Policy **insights transferable to costing and designing regulation.**

Consumer Demand Modeling: Impact of Water Pollution on Recreation and Housing Demand

Estimated demand for water quality across the US. Modeled demand with a combination of house price hedonic and discrete choice recreation demand models using national data of home sale prices, cellphone mobility, and satellite and in situ water quality. Demand modeling **applicable to welfare estimates of product characteristics or defects.**
